Due to the expiration of the charter, there were no committee meetings held in FY18.

Establishing this committee was necessary to carry out the President's Executive Order directing the Federal Interagency Partnership to work with local and regional agencies to protect the natural, recreational, and ecological resources in the Lake Tahoe Region. No other structure exists that enables a broad representation of local, regional, tribal, and national interests to provide the kind of advice the Federal Interagency Partnership needs. In addition, the committee has been identified by the Lake Tahoe Restoration Act (Pub. L. No. 106-506) and the implementation agreement for the Southern Nevada Public Land Management Act of 1998 (SNPLMA) (Pub. L. No. 105-263) as essential in providing advice and recommendations to the Partnership in implementing both acts and the Federal share of the Environmental Improvement Program at Lake Tahoe.
