20a. How does the Committee accomplish its purpose?

The AU BoV provides independent advice and recommendations on educational and doctrinal and research policies and activities of Air University. The AU BoV reviews and evaluates the progress of the education programs; the published statement of purpose, institutional policies, and financial resources; and the educational effectiveness, quality of student learning, administrative and educational support services as well as the teaching, research, and public service of the University. Recommendations made by the BoV are reviewed by the school or organization to which it pertains. That school or organization responds in writing to the BoV indicating how they will respond to the Board's recommendations. These actions are provided to the Secretary of Defense through the Secretary of the Air Force. This cycle provides a vital review of the quality of AU programs.

20b. How does the Committee balance its membership?

Air University maintains a balanced membership on the Board primarily on the basis of professional expertise and how this expertise bears on our education programs. For example, members of the Air Force Institute of Technology (AFIT) Subcommittee of the Board are chosen from engineering, management, and other academic areas offered at AFIT. These members are usually at the dean or professional level in their respective academic institutions. The rest of the AU BoV is composed of carefully selected individuals ranging from academic deans to chancellors of multi-university institutions (i.e., positions analogous to that of the AU Commander). We attempt to have some members knowledgeable of accrediting agencies to assist us in maintaining up-to-date knowledge of accrediting procedures and requirements. Finally, to round out the Board, retired military and business professionals are added. When considering the above categories of individuals, we maintain diversity representation insofar as possible, as well as geographical and institution type balance. Typically, 1/3 representation is attempted for educators, business professionals, and retired military respectively.

20c. How frequent and relevant are the Committee Meetings?

The average number of combined committee and subcommittee meetings is four (4) per year: Spring and Fall BoV Committee meetings and two Subcommittee meetings: one annual meeting at AFIT and one annual CCAF meeting. Bov Committee meetings are normally held at Maxwell AFB to review Air University programs. However, the Board may

occasionally meet at other locations. The Community College of the Air Force (CCAF) Subcommittee meets annually (the inaugural meeting was held in February 2017) and will normally meet at the Maxwell-Gunter AFB Annex, in Montgomery, Alabama. The Air Force Institute of Technology (AFIT) subcommittee meets annually (this meetings moved to October in CY2016) and is normally held at AFIT campus on Wright-Patterson AFB in Dayton, Ohio. These educational institutions have continuously evolving programs that require periodic reviews. Air University is accredited by the Southern Associations of Colleges and Schools Commission on Colleges and Higher Learning Commission. Also, some of the schools carry credit recommendations by the American Council on Education. These accrediting associations require, as part of their prescribed standards, periodic review by such external Boards for continued accreditation. The officers of the Board, and the Commander and President of Air University out-brief the Secretary of Defense through the Secretary of the Air Force and the Chief of Staff, USAF, each year following both the meetings (Wright-Patterson AFB and Maxwell AFB). This assures that IAW the Charter, the independent advice and recommendations of the Board may be acted upon by the Secretary of the Air Force.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The recommendations and consultations provided by the Board cannot be obtained elsewhere in the Air Force or the Department of Defense. It is the external, civilian, unbiased nature of the Board which makes it a valuable body. It is outside the normal DOD chain of command and can, therefore, bring a unique perspective to all areas it reviews. Board members are chosen on individual merit and the expertise they can offer Air University. Views and recommendations of the Board which are obtained during meeting discussions, as well as in the Board report, provide unique appraisals of AU's professional education and research programs. The members' collective experience of educational objectives and programs bring a reservoir of knowledge and understanding which is essential in education and to AU's relations with the general public and the academic community. The Air Force learns much from these experts and at the same time gains the respect of the civilian education environment by our willingness to consider the Board's advice. The counsel of the Board is invaluable in assisting and maintaining the proper academic levels for our programs. The functions and purpose of the BOV do not duplicate those of any other existing committees or agencies of the federal government.

20e. Why is it necessary to close and/or partially closed committee meetings?

Meetings are not closed to the public unless the Department of Defense determines that items on the planned agenda meet the closed meeting provisions of 5 U.S.C. § 552b(c).

Pursuant to DoD policy closed meetings can only be authorized by the DoD Sponsor, who is the Secretary of the Air Force or designee, and only after consultation with the appropriate General Counsel.

21. Remarks

The AU BoV Chairs out-brief the Secretary of the Air Force in-person, annually via an Executive Summary. Meeting minutes, which contain the Board's recommendations are attached as supporting documentation. For continuity and flow, Subcommittee Meeting minutes, after being approved by the Subcommittee, signed by the subcommittee Chair, and briefed to the main committee, are included annually as a separate and distinct attachment to the BoV minutes. (Historically, this has been the April [spring] meeting; in 2016 the Subcommittee meeting moved to Oct. therefore, the minutes will be attached to the November [the fall] main committee minutes.) The Board's current charter is being amended to reflect a change in the number of parent board meetings and the number of subcommittee meetings for the Board's existing subcommittee and the new subcommittee authorized by the Secretary of the Air Force.
