**20b. How does the Committee balance its membership?**

The Working Group shall be comprised of no more than 25 members representing the following interests and/or entities: Members representing the States or State law enforcement officials.

These members shall comprise the majority of the Working Group (i .e., no less than 51 percent);Members representing the FMCSA-regulated motor carrier industry;

Members representing organized labor; Members who are safety advocates or represent safety advocacy organizations; and Members representing other interested parties.

**20c. How frequent and relevant are the Committee Meetings?**

The Working Group meets three times in public sessions each year.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The Working Group reviewed the data elements of post-accident reports for tow-away accidents required to be reported to the Federal Motor Carrier Safety Administration (FMCSA) and that involve FMCSA-regulated commercial motor vehicles. With its unique expertise, including a majority of law enforcement members, as mandated by the FAST Act, the committee made recommendations to FMCSA and DOT on ways to improve reporting of crash data.

As a result of the PAR meetings, and the inclusion of NHTSA in these meetings, FMCSA and NHTSA established a workgroup to carry out the PAR's recommendations in January 2017. The workgroup meets occasionally to identify the best way to incorporate the PAR's recommendations into the Minimum Model Uniform Crash Criteria (MMUCC), NHTSA's voluntary standard that describes motor vehicle crashes that can be used to generate information to improve highway safety in the US.
