20a. How does the Committee accomplish its purpose?

MERPAC makes recommendations that influence the development of Coast Guard regulations and policies affecting personnel in the US Merchant Marine, including but not limited to: training, qualifications, certification, documentation, and fitness standards. The Committee provides valuable advice to the Secretary of the Department of Homeland Security and Commandant, USCG to assist the U.S. in formulating and presenting its positions to the International Maritime Organization on maritime matters. Specifically, MERPAC continues its work in support of the Coast Guard's efforts to bring the United States into full compliance with the 2010 amendments to the International Convention for Standards of Training, Certification and Watchkeeping for Seafarers, 1978 (STCW). In doing so, the Committee has continued to provide recommendations regarding methodologies for determining mariner competency which are valuable in helping formulate upcoming regulatory projects and guidance documents to support regulations. MERPAC also developed examples of model performance standards for in excess of fifteen areas of knowledge and proficiency in Table A of STCW giving priorities to those tasks best assessed aboard ship. The Committee continues its work on the utilization of military sea service in obtaining STCW certificates and mariner license and document reorganization.

20b. How does the Committee balance its membership?

The Committee membership is mandated by statute and consists of not more than nineteen (19) members who are appointed by the Secretary of the Department of Homeland Security. To assure a balanced representation, members are appointed, insofar as practicable, from the following groups and in the following numbers:

- a. Nine United States citizens with active licenses or certificates issued under chapter 71 or merchant mariner documents issued under chapter 73, including: (1) Three deck officers who represent the viewpoint of merchant marine deck officers, of whom: Two shall be licensed for oceans any gross tons; one shall be licensed for inland or river routes with a limited or unlimited tonnage; two shall have a master's license or a master of towing vessels license; one shall have significant tanker experience; and, to the extent practicable, one shall represent the viewpoint of labor and another shall represent a management perspective;
- (2) Three engineering officers who represent the viewpoint of merchant marine engineering officers, of whom: Two shall be licensed as chief engineer any horsepower; one shall be licensed as either a limited chief engineer or a designated duty engineer; and, to the extent practicable, one shall represent a labor viewpoint and another shall represent a management perspective;
- (3) Two unlicensed seamen, of whom: One shall represent the viewpoint of able bodied seamen; and another shall

represent the viewpoint of qualified members of the engine department; and, (4) One pilot who represents the viewpoint of Merchant Marine pilots;b. Six marine educators, including: (1) Two who represent the viewpoint of State maritime academies and are jointly recommended by such State maritime academies; (2) One who represents either the viewpoint of the State maritime academies or the United States Merchant Marine Academy; and (3) Three marine educators who represent the viewpoint of other maritime training institutions, one of whom shall represent the viewpoint of the small vessel industry;c. Two individuals who represent the viewpoint of shipping companies employed in ship operation management; and,d. Two members who are drawn from the general public.

20c. How frequent and relevant are the Committee Meetings?

MERPAC usually meets twice annually, and work groups frequently meet between the semi-annual meetings. MERPAC is composed of experts in their particular segment of the merchant marine industry, and the Committee makes recommendations that influence the development of Coast Guard regulations and policies affecting personnel in the US Merchant Marine, including but not limited to: training, qualifications, certification, documentation, and fitness standards. The Committee provides valuable advice to the Commandant,USCG to assist the U.S. in formulating and presenting its positions to the International Maritime Organization on maritime matters. MERPAC has significantly facilitated the US Coast Guard's implementation of the 2010 Amendments to the International Convention on the Standards of Training, Certification & Watchkeeping for Seafarers (STCW) with harmonization of ongoing U.S. regulations. This harmonization has required an extensive revision of U.S. licensing and documentation regulations. The US Coast Guard's effectiveness in these activities is greatly improved with direct access to the expertise and advice that is currently represented on this advisory Committee.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This diverse Committee provides focused and well thought-out recommendations to relevant issues. It is very responsive to the US Coast Guard's need for recommendations on short turn-around issues. The unique industry perspective provided by this Committee facilitates the US Coast Guard's efforts. This information would otherwise have to be drawn from the broad population involved in merchant vessel personnel matters. There is no other current entity which can provide the level of technical expertise and experience that is afforded by this advisory panel.

Until December 18, 2014, Merchant Marine Personnel Advisory Committee (MERPAC) performed as a discretionary committee. As part of the Howard Coble Coast Guard and Maritime Transportation Act of 2014, PL-113S2444, Section 310, this committee became statutory with minor change from its discretionary authorization. The existing and current charter was amended and filed with Congress on 17 January 2017. Its expiration date is 17 January 2019.
