**20a. How does the Committee accomplish its purpose?**

The MEP Advisory Board is authorized under Section 3003(d) of the America COMPETES Act (P.L. 110-69), as amended by the American Innovation and Competitiveness Act, P.L. 114-329 sec. 501 (2017), and codified at 15 U.S.C. § 278k(m), in accordance with the provisions of the Federal Advisory Committee Act, as amended, 5 U.S.C. App. The purpose of the Board is to provide advice on MEP's program, plans and policies, to assess MEP's plans and strategies, and to assess current performance against program plans. The committee accomplishes this through informational briefings by MEP staff and external presenters at regular Board meetings. External presenters often include program stakeholders and partners as well as experts on manufacturing trends and challenges. These meetings are often held in conjunction with other MEP National Network events to provide Board members the opportunity to interact with representatives from individual MEP centers. These interactions provide the Board with the perspectives and feedback from a key stakeholder group.

**20b. How does the Committee balance its membership?**

The membership consists of individuals broadly representing the program's stakeholders. At least two members serve on advisory boards for MEP centers. At least 5 members represent small manufacturing establishments. At least 1 member represents a community college. Additional members represent stakeholders involved in industrial extension through academia, technology deployment, and workforce activities. MEP actively seeks nominations for Board members from partners, MEP centers and other stakeholders.

**20c. How frequent and relevant are the Committee Meetings?**

The Board meets at least biannually, but usually three times each year. Additional meetings may be called by the NIST Director. These meetings are often held in conjunction with other MEP-National Network events to provide Board members the opportunity to interact with representatives from individual MEP centers. These interactions provide the Board with the perspectives and feedback from a key stakeholder group.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The Board provides the critical advisory role necessary for a program focused on the needs of the manufacturing industry, in particular smaller manufacturers. The Board provides a key role by assessing the performance of the program against its plans and

strategies and provides advice on policy, long-term strategy, and program implementation. Only an external Board with a membership firmly planted in the multiple dimensions of industrial extension could provide this needed feedback.
