20a. How does the Committee accomplish its purpose?

The Board advises the Secretary of Commerce on government policies and programs that affect the U.S. travel and tourism industry, including ways to ensure the United States remains a preeminent destination for travel and tourism. The Board acts as a liaison to the stakeholders represented by the membership, consulting with them on emerging issues in the industry to support sustainable travel and tourism growth, and providing a forum for discussing and proposing solutions to industry-related problems. The Board provides recommendations to the Secretary regarding U.S. travel and tourism.

20b. How does the Committee balance its membership?

Members represented companies and organizations in the travel and tourism sector from a broad range of products and services, company sizes and geographic locations, and drew from large, medium and small travel and tourism companies, private-sector organizations involved in the export of travel and tourism-related products and services, and other tourism-related entities.

20c. How frequent and relevant are the Committee Meetings?

Estimated Number of Meetings per Year: 4. The relevance of regular meetings allows the private sector members to address policy areas that continue to or newly affect the travel and tourism industry. Regular meetings also allow the Department of Commerce and other member of the inter-agency Tourism Policy Council to review and respond to the Board's recommendations. The Board completes its work in subcommittees that are not separately chartered and that refer and convey work through the full Board. They meet via teleconference or in-person between Board meetings. There are no members of

subcommittees that are not members of the Board. These subcommittees do not incur costs separate to that to run the committee and to staff the official meetings.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This Committee is essential to advise the Secretary on promotion activities as directed by P.L. 108-7, Section 10 and to achieve the broader function of the charter of this discretionary committee. There is no other body which can provide this advice to the Secretary.

20e. Why is it necessary to close and/or partially closed committee meetings?

All meetings are open to the public.
