Purpose Start End

Seven members of the Wrangell-St. Elias National Park Subsistence Resource Commission attended the meeting. Other participants included 13 members of the park staff, 4 staff from the NPS Alaska Regional Office, 9 members of the public, and 7 representatives of other agencies, tribes, and organizations. The meeting agenda included opportunities to review and comment on federal subsistence fisheries proposals and a Nelchina caribou ANILCA section 804 user prioritization analysis. The commission made recommendations regarding updates for the Superintendent's Compendium as well as proposals to the Alaska Boards of Fisheries and Game. It also heard reports from the Superintendent, the Division of Interpretation and Education, the Research Stewardship and Science Team, and the NPS Alaska Region Subsistence Program. Staff from the Ahtna Intertribal Resource Commission and the Bureau of Land Management Glennallen Field Office provided reports on staffing and activities.

20a. How does the Committee accomplish its purpose?

Federal law and regulation provide the opportunity for continued subsistence uses, including hunting, within the Wrangell-St. Elias National Park. The Subsistence Resource Commission for Wrangell-St. Elias National Park is a forum that promotes effective communication and mutual understanding of subsistence uses and related cultural resources. The Commission consults with every appropriate local advisory committee and regional council for comment and input on draft hunting plan recommendations. In addition to the advisory committee and regional council consultation process directed by P.L. 96-487 (the Alaska National Interest Lands Conservation Act), the Commission is required to hold public meetings in all areas affected by the subsistence hunting program.

20b. How does the Committee balance its membership?

Membership, as prescribed by the Commission's enabling legislation, consists of nine members as follows: (a) three members appointed by the Secretary of the Interior; (b) three members appointed by the Governor of Alaska; and (c) three members appointed by the regional council,

as established by the Secretary or the Governor pursuant to section 805 of P.L. 96-487. The members include a range of individuals having personal knowledge of the region's subsistence conditions, and having an interest in Federal subsistence management.

20c. How frequent and relevant are the Committee Meetings?

Meetings are generally held twice a year, or as often as circumstances require. Commission recommendations are vitally important on matters relating to the taking of wildlife within the park, and are the foundation for the development and review of the subsistence hunting program.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Commission's recommendations help the NPS to ensure the continuation of the opportunity for local rural residents to engage in the subsistence use of resources in Wrangell-St. Elias National Park and Preserve. The NPS has adopted the following mission statement to guide its activities. Subsistence will be managed as a legislated use consistent with the provisions of ANILCA, the Organic Act of 1916, and park's enabling legislation to: protect the opportunity for qualified local rural residents to continue traditional subsistence activities; recognize that subsistence ways of life differ from region to region and arecontinuing to evolve, and where appropriate, park management practicesmay reflect regional diversity and evolution; promote local involvement and participation in processes associated withsubsistence management; ensure that management practices involving the utilization of public landsadequately consider the potential for restriction of subsistence uses and impacts

upon subsistence resources; ensure that management of park resources is consistent with the conserva-tion of unimpaired ecosystems and natural and healthy populations of fishand wildlife, incorporating scientific data and principles with traditionalknowledge and cultural values; and promote effective communication and mutual understanding of subsistenceuses and related cultural and social values, and park purposes and protection, between the NPS, subsistence users, the State of Alaska and the public.

20e. Why is it necessary to close and/or partially closed committee meetings? All meetings are open.

21. Remarks

The Wrangell-St. Elias Subsistence Resource Commission met once during fiscal year 2024. This meeting was held on March 14 and 15, 2024 in Gakona, Alaska, in person and via teleconference. There was only one meeting held in FY24 due to the Fall meeting being moved to the alternate date in October, thus moving the associated reporting to FY25. The following recommendations and motions were passed during the spring 2024 meeting: o A motion was passed to submit a temporary special action request to the Federal Subsistence Board for a one-year closure to hunting of the Nelchina caribou herd in Unit 11, Unit 12 remainder, and Unit 13 for all users and request an ANILCA Section 804 user prioritization analysis using state and federal harvest data. o A motion was passed to submit a temporary special action request to the Federal Subsistence Board to extend the fall moose season in Unit 12 – that portion within the Tetlin National Wildlife Refuge and those lands within Wrangell St. Elias Preserve north and east

of Pickerel Lake Winter Trail – to September 30 for the 2024-25 and 2025-26 regulatory years. o A motion was passed to submit a Board of Game proposal to extend the trapping seasons for wolf and coyote in Unit 11 (November 10 to March 31) to match the season lengths in Units 12 and 13 (October 15 to April 30). o Comments were developed through a consensus process regarding a proposed rule to add three public member seats to the Federal Subsistence Board and then ratified with a motion to reference these comments in their letters to the Secretary of the Interior and the Governor of Alaska. o A motion was passed to write a letter to the Secretary of Interior and the Governor of Alaska highlighting actions taken during the meeting, including commenting on the proposed rule to add seats to the Federal Subsistence Board, deferring action on proposed changes to the Superintendent's Compendium regarding resident zone boundaries to the fall meeting, submitting temporary special action requests to the Federal Subsistence Board, and submitting a proposal to the Alaska Board of Game. Additional comments: The commission discussed proposed changes to the Superintendent's Compendium. It also heard reports from the Superintendent, the Division of Interpretation and Education, the Research Stewardship and Science Team, and the NPS Alaska Region Subsistence Program. Staff from the Ahtna Intertribal Resource Commission, the Alaska Department of Fish and Game, Tetlin National Wildlife Refuge, and the Bureau of Land Management-Glennallen Field Office. In addition to the recommendations described above, the commission approved motions to adopt the meeting agenda, to approve the minutes from its September 2023 meeting, and to adjourn the meeting. The commission re-elected SRC Chair

Sue Entsminger and elected SRC Vice-Chair Suzanne McCarthy. The commission deferred action on the proposed Superintendent's Compendium entry on resident zone boundaries to the fall meeting. The next meeting was tentatively scheduled for September 23 and 24, 2024, with October 4 and 5, 2024, as alternate dates. If an in-person meeting can be held, it will be in Copper Center, AK.
