20a. How does the Committee accomplish its purpose?

The Senior Advisor for Environmental Management directs the Board to provide input, advice, and recommendations on various programmatic issues. In FY 2023, the Board voted to submit recommendations on three topics: EM's hybrid work environment, employee recruitment and retention, and a technology development roadmap for Hanford's tank waste. In support of its mission, members held an open, public meetings on December 1, 2022 in New Orleans, LA and May 22, 2023 via teleconference.

20b. How does the Committee balance its membership?

Board members represent a variety of experience

and expertise, including that of regulatory agencies, business and industry, academia, professional associations, and state, local, and tribal governments. In addition, the Board seeks assistance and input from stakeholder representatives and technical consultants.

20c. How frequent and relevant are the Committee Meetings?

The full Board meets semi-annually or as deemed appropriate by the Senior Advisor. In FY 2023, EMAB held two public meetings. During full Board meetings, proposed recommendations to the Senior Advisor are discussed and agreed upon in an open, public forum. These meetings also provide an opportunity for private citizens and other interested audiences that are not members of the Board to understand issues relevant to the EM program.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

EMAB is the advisory body charged with providing advice and recommendations directly to the Senior Advisor on corporate issues related to the entire EM program. These issues include, but are not limited to: project management and oversight activities, cost/benefit analyses, program performance, human capital development, science and technology, and contracts and acquisition strategies.
