20a. How does the Committee accomplish its purpose?

The Board assists and advises the Secretary of the Interior, through the Director of the BLM, and the Secretary of Agriculture, through the Chief of the Forest Service, on wild horse and burro policy formulation and oversight of the Wild Horse and Burro Program administered under the provisions of the Act.

20b. How does the Committee balance its membership?

The Advisory Board membership is balanced in terms of categories of interest represented and geographic locations. Each member, who, based on their professional background, training, experience and/or affiliation, has knowledge or

special expertise that qualifies him or her to provide advice from among the listed categories. Advisory Board members who serve as representatives are in the positions of wild horse and burro advocacy; wild horse and burro research; humane advocacy; wildlife management; livestock management; natural resource management; veterinary medicine; and two positions representing public interest: one with a focus on equine behavior and one with a focus on protection of wild horses and burros, management of wildlife, animal husbandry and/or natural resource management.

20c. How frequent and relevant are the Committee Meetings?

The Advisory Board generally meets twice a year, and may meet up to four times a year according to the Charter if the DFO deems necessary. The Committee meetings are highly relevant, providing the BLM and the USFS with recommendations aimed at addressing the most pressing issues and needs.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Advisory Board gathers and analyzes current information on wild horse and burro management and considers relevant public comments in order to offer advice and develop recommendations from a national perspective for the Secretary of the Interior, the Director of the Bureau of Land Management, the Secretary of Agriculture, and the Chief of the Forest Service on the management and protection of wild horses and burros.

20e. Why is it necessary to close and/or partially closed committee meetings?

Analysis has not been done to determine cost savings associated with the Wild Horse and Burro Advisory Board. However, the recommendations made by the Board are highly valued by the BLM and the Forest Service and have an influence on strategic direction

and program priorities.

Number of Recommendations Comments

The Board made the following 6 recommendations at the October 2022 meeting: the BLM and FS should centralize the WHB Programs and institute organizational changes that would increase their program effectiveness; the BLM and FS develop a definitive reporting process for the public to report potential animal welfare or adoption violations; the BLM continues to investigate vouchers as incentives for the Adoption Incentive Program; the BLM and FS investigate an agency avenue to build local partnerships/coalitions to support wild horse and burro care, ensure compliance and provide post adoption support; the BLM and USFS work with United States Geological Survey scientists to identify HMAs and Territories that will provide a statistically meaningful sample with which to test and validate the PopEquus model, under a diversity of field conditions, and that efforts begin immediately; and that the BLM use measurable objectives outlining targeted fertility control and multi-year plans for individual HMAs or territories. The Board made the following 8 recommendations at the June 2023 meeting: the BLM and the USFS develop operational plans outlining how robust, meaningful, programmatic fertility control will be incorporated into HMA and Territory management plans; the BLM and USFS begin determining the process of analysis that will enable locally relevant, short- and long-term range health considerations to guide decisions towards determining AML; the BLM and the USFS should further centralize their respective WH&B programs to increase the program's effectiveness and their ability to respond to emergencies; the BLM and the USFS explore creative ways to garner additional funding sources and capacities (as allowed by law or statute) outside of the appropriations process that will enable effective management of horse and burro populations; the BLM and USFS request consultations with Tribal Governments and initiate and/or maintain discussions with other government entities responsible for management of free-roaming horse populations to ensure actions taken in HMAs and on Territories are not undermined by emigration or immigration of horses and burros from other areas; the USFS continue to advocate for its own separate budget for management of wild, free-roaming horses and burros, given that 20% of the total free-roaming population is on USFS land; the Board supports the commitment of the agency to the CAWP and recommends continuing internal training and increasing the level of public educational opportunities; and the Board recommends continually refining and improving the level of care, handling and treatment provided by the WH&B Program.
