20a. How does the Committee accomplish its purpose?

The committee's objectives and scope of activities include: (1) advising the FCAH of policy options related to the administration of the Arts and Artifacts Indemnity Act; (2) reviewing and recommending for approval applications for Federal indemnity; (3) providing expert judgment with respect to the dollar valuation, the adequacy of packing, shipping, and security arrangements, and the cultural, historical, educational, and scientific significance of the objects to be indemnified; and (4) reviewing and advising the FCAH on claims submitted or payments made under the Arts and Artifacts Indemnity Act. The FCAH is authorized to make indemnity agreements to cover loss or damage for a single exhibition up to \$1.8 billion, with an aggregate amount of agreements not to exceed \$22.5 billion at any one time. Exhibitions that may be indemnified are: works of art, including tapestries, paintings, sculpture, folk art, graphics and craft arts; manuscripts, rare documents, books and other printed or published materials; other artifacts; photographs, motion pictures, or digital

materials.

20b. How does the Committee balance its membership?

The committee is comprised of museum curators, directors, registrars, and conservators. Members are chosen for their expertise in organizing traveling exhibitions, knowledge of the international art market and valuations, and judgment about minimizing risks to the Treasury. Curators have specific areas of expertise (e.g., European art, modern art, decorative arts, sculpture) in order to judge valuations. Additional considerations for committee membership include the size and type (public or private) of the museum from which the member is chosen, as well as the museum's geographic location.

20c. How frequent and relevant are the Committee Meetings?

The panel meets four times a year. These meetings occur prior to the meetings of the Federal Council on the Arts and the Humanities.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

Because of the uniqueness of the Arts and Artifact Indemnity Program and the questions that arise concerning security, valuations, and transportations of art and artifacts, the advice obtained from the panel could not be obtained from any other source.

20e. Why is it necessary to close and/or partially closed committee meetings?

The Arts and Artifacts Indemnity Panel reviews applications for indemnity for exhibitions of art and artifacts traveling to and from the United States, as well as domestic exhibitions. It is essential to

keep the values of objects to be indemnified, methods of transportation, and museum security measures confidential in order to protect these artifacts and works of art from loss or damage.
