**20a. How does the Committee accomplish its purpose?**

The Advisory Committee on Construction Safety and Health (ACCSH) accomplishes its purpose by conducting open work group and full committee meetings. In order to attract the broadest participation, the Agency publishes press releases, contacts interested parties by email and publishes the required Federal Register meeting notices. Also, the Agency relies on interested parties and associations to pass the notices on to colleagues and members. The work groups engage in research, hold open discussions, receive presentations, produce materials, deliberate suggestions, and regularly report their activities to the full committee. ACCSH members who represent different interests (Employer, Employee, Public, State Agency, and Federal Agency) co-chair the work groups. The full committee discusses the work group activity reports, and takes appropriate action, which can include: further research, more analysis/deliberation, and recommendations to the Agency. The Agency routinely asks ACCSH to make recommendations or provide advice on specific construction-related policy matters. To provide the greatest possible reach for ACCSH discussions and materials, the Agency posts meeting minutes, transcripts, presentations, other meeting information, and work group reports in the meeting docket. **20b. How does the Committee balance its membership?**

The Secretary of Labor appoints 15 members to ACCSH; five qualified by experience and affiliation to represent the view points of employers involved in construction, five qualified by experience and affiliation to represent the view points of employees involved in construction, two representing State safety and health agencies, two members of the public who are qualified by knowledge and experience, and one member designated by Secretary of the Department of Health and Human Services (HHS) to represent the federal sector. The HHS designee is usually from the National Institute for Occupational Safety and Health (NIOSH). Members are appointed to serve up to two-year terms.

**20c. How frequent and relevant are the Committee Meetings?**

ACCSH meets two to four times a year as a full committee. It maintains a schedule to direct and receive the deliverables of its work groups (the work groups take direction from and report to the full committee, not the Agency). Additionally, since the meetings are open to the public, regular ACCSH meetings effectively provide public updates as well as

broad-based construction industry input through public comments. Most work group meetings are held in conjunction with the full committee meetings, but some meet at alternate times and locations. These work group meetings, for example, may deal with individual issues, site visits, novel technology familiarization, or the need to prepare complex materials for the full Committee's consideration. No regulatory items required ACCSH to meet during FY 2018.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

ACCSH is a continuing advisory body mandated by law under section 107 of the Contract Work Hour and Safety Standards Act (40 U.S.C. 3701 et.seq), known as the Construction Safety Act. ACCSH is necessary to advise the Secretary of Labor and Assistant Secretary for Occupational Safety and Health on how the development and implementation of safety and health standards, regulations and policies could affect the construction industry.

**21. Remarks**

ACCSH is a continuing non-discretionary advisory committee to satisfy the requirements of the Construction Safety Act and its ongoing requirement for the Agency to seek the Committee's advice and recommendations concerning construction safety and health standards as well as associated policy matters. Pursuant to Section 107 of the Contract Work Hours and Safety Standards Act (Construction Safety Act)(40 U.S.C. 3701 et seq.) at Section 107(e)(1) "[t]he Secretary [of Labor] shall establish in the Department of Labor an Advisory Committee on Construction Safety and Health ..." There is no termination authority in the language. In addition, pursuant to Section 107(e)(2) the "committee shall advise the Secretary in the formulation of construction safety and health standards and other regulations, and with respect to policy matters arising in the administration of this section. Department of Labor regulations at section 29 CFR 1912.3(a) maintain in addition to the Construction Safety Act requirements that because "of the far reaching coverage of the Construction Safety Act, the myriad of standards that may be issued thereunder, and the fact that the Construction Safety Act would also apply to much of the work which is covered by the Williams-Steiger Occupational Safety and Health Act of 1970, whenever occupational safety or health standards for construction activities are proposed, the Assistant Secretary shall consult the Committee."

ACCSH has been active for nearly 50 years. Therefore, it is difficult to truly approximate the total number of recommendations produced by the Committee. ACCSH did not meet in fiscal year (FY) 2018. ACCSH provided seven recommendations to the Agency in FY 2017. One of the highlights of the FY 2017 recommendations was their support of OSHA's proposed rule to extend the enforcement date for the crane operator certification requirements and existing employer duty in the cranes and derricks standard to November 10, 2018. ACCSH has produced numerous other recommendations over the years that have enhanced the safety of workers in the construction industry. For instance, in FY 2016, ACCSH made recommendations that were included in OSHA's publication of the Recommended Practices for Safety & Health Programs in Construction guidance/outreach product. In FY 2015, ACCSH recommended the Agency proceed with rulemaking to clarify that the duty to make and maintain accurate records of work-related injuries and illnesses is an ongoing obligation in 29 CFR Part 1904 - Recording and Reporting Occupational Injuries and Illness. In FY 2014, OSHA enhanced the Introduction module of the OSHA 10 hour course based on recommendations initiated by ACCSH. The Committee made the following recommendations to OSHA in fiscal year 2017: #1. 20-Jun-17: ACCSH recommended that OSHA proceed with proposed rulemaking to extend the enforcement date for the crane operator certification requirements and existing employer duty in the cranes and derricks standard to November 10, 2018. #2. 1-Dec-16: ACCSH recommended that OSHA establish two working groups, one on training and one on outreach. #3. 1-Dec-16: ACCSH recommended that OSHA proceed with rulemaking on § 1401 and to clarify, modify, or add an exemption to make clear that the standard would not prohibit employees from using a stationary, suspended load as a walking/working surface. #4. 1-Dec-16: ACCSH recommended that OSHA proceed with Cranes Amendments rulemaking and consider exempting the use of load weighing, anti two-blocking, and similar devices as discussed during this meeting. #5. 1-Dec-16: ACCSH recommended that OSHA proceed with Cranes Amendments rulemaking using the language in the recommended amendment to the personnel hoisting section of the cranes standard. The language would make personnel bucket criteria of the cranes standard consistent with that in the aerial lift standard and current best practices of the industry. #6. 1-Dec-16: ACCSH recommended that OSHA proceed with the Cranes Amendments rulemaking using the language as proposed for the section for Floating Cranes and Cranes on Barges or other means of floatation. The language would clarify that workers on surfaces other than the deck of a barge-mounted or floating crane must be protected from the load falling from the crane's load line. #7. 1-Dec-16: ACCSH recommended that

OSHA proceed with proposed rulemaking (Railroad Cranes) that would expand exemptions for railroad cranes per the railroad cranes litigation and settlement agreement.
