Consistent with the Executive Order, the Commission was established to advise the President and the Secretary of Education in the following areas: (i) developing, implementing, and coordinating educational programs and initiatives at the Department and other agencies to improve educational opportunities and outcomes for

African Americans of all ages;(ii) increasing the engagement of the African American community and institutions that serve the African American community in the Department's programs and education programs at other agencies; (iii) engaging the philanthropic, business, nonprofit, and education communities in a national dialogue on the mission and objectives of the Executive Order; and (iv) establishing partnerships with public, private, philanthropic, and nonprofit stakeholders to meet the mission and policy objectives of the Executive Order.

**20b. How does the Committee balance its membership?**

The Commission consisted of not more than 25 members appointed by the President. President Obama appointed members and designated one member of the Commission to serve as Chair.

**20c. How frequent and relevant are the Committee Meetings?**

Per Executive Order 14048, the Commission was continued until September 30, 2023. However, per Executive Order 14050, the Commission was terminated.

The Committee advised the White House Initiative on Educational Excellence for African Americans on matters pertaining to national outcomes for African Americans of all ages, to help ensure all African Americans receive an education.
