20a. How does the Committee accomplish its purpose?

Section 492 of the PHS Act states that the The Secretary...shall by regulation require appropriate technical and scientific peer review of -- (A) applications...; and (B) ...biomedical and behavioral research and development contracts... This Board is composed of both scientific and public members who provide the second level of peer review; advise on policy development, program implementation and evaluation; and identify research needs and opportunities of the Center. The FIC Advisory Board, through planning discussions at the Board meetings and through the organization and co-management of working groups was instrumental in the development of several program initiatives, helping to identify institutional needs and promising areas of scientific pursuit. These include Fogarty's HIV Research Training Programs for Low- and Middle-Income Country Institutions; Global Infectious Disease Research Training Programs; International Bioethics Research Training Program and Education and Curriculum Development Award; Global Brain and Nervous System Disorders Research across the Lifespan Programs; Reducing Stigma to Improve HIV/AIDS Prevention, Treatment and Care in Low- and Middle-Income Countries Program; Mobile Health: Technology and Outcomes in Low and Middle-Income Countries Program; NIH-NSF Ecology and Evolution of Infectious Diseases Initiative; Global Non-Communicable Diseases and Injury Across the Lifespan Programs; African Association for Health Professions Education and Research Initiative; Health-Professional Education Partnership Initiative; Emerging Global Leader Award; and International Research Scientist Development Award. During this reporting period the FICAB reviewed 154 applications for programs, requesting \$456,637,457.

20b. How does the Committee balance its membership?

The Fogarty International Center Advisory Board is composed of 13 appointed members with research interests and responsibilities paralleling those of the Fogarty International Center. 10 members are scientists who are outstanding medical or scientific authorities knowledgeable in the fields of tropical disease, public health, molecular parasitology, preventive medicine, international health policy, nutrition, and epidemiology. Three members are from the general public and include leaders in fields of health-related enterprises such as pharmaceutical or life insurance companies, voluntary organizations committed to better public health, international health, and international health law. Close attention is given to equitable geographic distribution and to ethnic and gender representation so long as the effectiveness of the Board is not impaired. Appointments shall be made without discrimination on the basis of age, ethnicity, gender, sexual

orientation, disability, cultural, religious, or socioeconomic status.

20c. How frequent and relevant are the Committee Meetings?

Meetings are held approximately three times each fiscal year. The Fogarty International Center Advisory Board provides advice on a continuing basis on the type of scientific research programs that should be supported and on how to carry out the designated mission and responsibilities of the Center. It also provides ongoing review of the relevance and effectiveness of the existing programs.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Fogarty International Center Advisory Board is composed of both scientific and public members who provide the second level of review for research grant applications; advise on policy development, program implementation and evaluation; and identify research needs and opportunities of the Center. The quality, scope, and balance of advice from this Board cannot be obtained from NIH staff or from other established sources because the membership of the council is constituted to meet the specific requirements of the mandated mission of the Board and of the Center.

20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the Fogarty International Center Advisory Board were closed to the public for review of grant applications. Sections 552b(c)(4) and 552b(c)(6) of the Government in the Sunshine Act permit the closing of meetings where discussion could reveal confidential trade secrets or commercial property such as patentable material and personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

The FIC Advisory Board, through planning discussions at the Board meeting and through the organization and co-management of working groups was instrumental in the development of several program initiatives, helping to identify institutional needs and promising areas of scientific pursuit. These include Fogarty's Framework Programs for Global Health, a network of 30 U.S. universities to build the multidisciplinary teams, curricula and infrastructure needed to conduct global health research in multiple schools on these campuses; the Fogarty International Clinical Research Scholars and Fellows Program, which trains U.S. medical/grad students/post-docs in biomedical/health fields to become investigators in Global Health research and Fogarty's Informatics Training Program to develop modern information technology to support health sciences research.

Action Comments

Research grant applications submitted to NIH must go through a two-step review process that includes the initial peer review for scientific and technical merit and a second step of review and approval by a National Advisory Council that includes program relevance. In addition, prior to an award or funding being made, NIH staff must conduct an administrative review for a number of other considerations. These include alignment with NIH's funding principles, review of the project budget, assessment of the applicant's management systems, determination of

applicant eligibility, and compliance with public policy requirements. After all these steps have been completed, NIH officials make funding decisions on individual grant applications.
