Section 492 of the PHS Act states that "The Secretary...shall by regulation require appropriate technical and scientific peer review of -- (A) applications...; and (B) biomedical and behavioral research and development contracts." This committee is composed of recognized biomedical and behavioral research authorities who represent

the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research funding applications and proposals, including but not limited to grant and cooperative agreement applications and contract proposals for research projects and for research and training activities in areas relevant to biophysics of neural systems, cellular and molecular biology of glia, cellular and molecular biology of neurodegeneration, molecular neuropharmacology, neurodifferentiation, plasticity, and regeneration, neurogenesis and cell fate neural oxidative metabolism and death, neurotransporters, receptors, and calcium signaling, and synapses, cytoskeleton and trafficking. During this reporting period the committee reviewed 1,481 applications requesting \$2,241,039,007.00

This committee is composed of recognized biomedical and/or behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and contract proposals. These evaluations and recommendations can not be obtained from other sources because the specialized, complex nature of the applications and proposals requires a unique balance and breadth of expertise not available on the NIH staff or from other established sources.

## 20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the committee were closed to the public for the review of grant applications. Sections 552b(c)(4) and 552b(c)(6) of the Government in the Sunshine Act permit the closing of meetings where discussion could reveal confidential trade secrets or commercial property such as patentable material and personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.
