# 20a. How does the Committee accomplish its purpose?

This Board interacts with the National Center for Medical Rehabilitation Research (NCMRR) Eunice Kennedy Shriver National Institute of Child Health and Human Development (NICHD) to advise the Center and the Institute as a whole on research opportunities, health needs, and other aspects of medical rehabilitation. The Board is composed of

highly qualified scientific and public members who represent many aspects of medical rehabilitation research, health policy, and support for individuals with chronic disabilities. Agendas for these meetings are carefully planned to maximize Board participation and constructive dialogue with NCMRR staff, ex officio members, and other interested parties. The Board has a specific role in providing concept clearance for upcoming NCMRR research initiatives and reviewing the implementation of the NCMRR research plan. The Board assisted the Center in identifying new research opportunities as part of its periodic Report to the Institute Council, which occurs every few years. The Board also has a major role in providing input to the NIH Research Plan for Rehabilitation Research and the NIH Rehabilitation Research Conference, which is updated approximately every five years.

### 20b. How does the Committee balance its membership?

The National Advisory Board on Medical Rehabilitation Research is composed of 18 appointed members and 12 ex-officio members for a total of 30 members. Twelve members are representatives of health and scientific disciplines with respect to medical rehabilitation. Six members are representatives in the interest of individuals undergoing, or in the need of, medical rehabilitation. The ex-officio members include: The Director, National Center for Medical Rehabilitation Research; The Director, Eunice Kennedy Shriver National Institute of Child Health and Human Development; The Director, National Institute on Aging; The Director, National Institute of Arthritis and Musculoskeletal and Skin Diseases; The Director, National Institute on Deafness and Other Communication Disorders;

The Director, National Heart, Lung, and Blood Institute; The Director, National Institute of Neurological Disorders and Stroke; The Director, National Institute on Disability, Independent Living and Rehabilitation Research (formerly National Institute on Disability and Rehabilitation Research), U.S. Department of Health and Human Services; The Director, Division of Program Coordination, Planning, and Strategic Initiatives, Office of the Director, National Institutes of Health; The Commissioner for Rehabilitation Services Administration, U.S. Department of Education; The Assistant Secretary of Defense for Health Affairs; and The Deputy Undersecretary for Health of the Department of Veterans Affairs.

### 20c. How frequent and relevant are the Committee Meetings?

The Board met twice during this reporting period on the following dates: December 4-5, 2023, and May 6-7, 2024, but because of COVID these meetings were shifted to a virtual and hybrid format, which also translated to a more abbreviated meeting. Agenda items are developed by NCMRR staff in conjunction with input from the Board to focus on topics that are particularly timely in the field of medical rehabilitation and relevant to improving the lives of people with disabilities. The agenda is a mix of informational and discussion sessions that often draw on the particular expertise and experiences of the Board members themselves with invited participants as needed. Minutes from each meeting are distributed to Board members and posted on the NCMRR website to invite further input from the rehabilitation community and general public.

## 20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Board is composed of recognized research authorities and leading advocates in the health care community. Because of the broad multidisciplinary nature of medical rehabilitation research and the convergence of biomedical, behavioral, psychosocial, and policy issues, recommendations could not be derived from individual sources in the biomedical or health community. Moreover, this information represents the integration of several viewpoints and balance among research and service priorities. The special nature of these deliberations and consensus of opinion could not be derived from individual interactions of other professional groups, nor developed by NIH staff alone.

#### **Number of Recommendations Comments**

The December 2023 NABMRR meeting was held in a two-day virtual/in-person hybrid format. The Board received updates about the NCMRR, NICHD, and NIH in general from the NCMRR Director and then the NICHD Director. The Board then discussed the need to update the NIH Strategic Plan for Rehabilitation Research, which occurs every five years. There was also a summary of the NABMRR Training Working Group that has specific recommendations for continued support of research training and career development. An outside speaker provided a first-hand account on supporting a child with traumatic brain injury and the need for including persons with the lived experience in research and knowledge translation. This was followed by a summary of a recent research retreat to promote engagement of the broader community to research translation. A representative of the Veterans Administration provided an update on VA research and collaborations with the NIH. The final session of the first day presented the report of the NIH Advisory Committee to the Director on including people with disabilities in research studies. The second morning began with a research presentation on psychosocial support for people with traumatic brain injury. This was followed by a three-part discussion of research on musculoskeletal injury rehabilitation. The Board made a total of 43 recommendations. The May 2024 NABMRR meeting was held in a two-day virtual/in-person hybrid format. The meeting began with updates about the NCMRR, NICHD, and NIH in general from the NICHD Director and the NCMRR Director. This was followed by a research talk and personal account of sports medicine for para- and adaptive-athlete. The Board got an

update on clinical nomenclature for traumatic brain injury research. The final presentation of the day provided concept clearance for an upcoming research initiate. The second day began with a research presentation and personal accounting cerebral palsy research. The Board then got a update from the NICHD Office of Health Equity. This was followed by updates on the NICHD Pediatric Medical Device Public Private Partnership and the relatively new Advanced Research Projects Agency for Health. The Board then discussed the NCMRR plan to receive public input into the periodic update of the NIH Strategic Plan for Rehabilitation Research. The Board made a total of 42 recommendations.
