20a. How does the Committee accomplish its purpose?

The Office of AIDS Research Advisory Council (OARAC) is composed of highly qualified individuals who possess scientific expertise in AIDS research and a public commitment to advance the AIDS scientific agenda. The Council provides a breadth and balance of specialized knowledge necessary to advise the Director of the Office of AIDS Research (OAR) and the Director of the National Institutes of Health (NIH). The NIH Revitalization Act of 1993 called for the establishment of OARAC to provide advice on planning, coordination, and evaluating AIDS research supported by the NIH and to advise on the awarding of funds from the OAR Discretionary Fund. The OAR depends heavily on the Council's advice in the extensive process of reviewing all NIH AIDS research and developing long-term research plans. To accomplish this, briefing sessions on specific topics that are timely and of relevance were presented during FY 2018 to update the OARAC on: Status of NIAID plans for the DAIDS-sponsored clinical trials networks, due to be re-competed in FY 2019; Status of plans for the MACS and WIHS prospective cohort studies which beginning in FY 2019 the NHLBI will manage awards for as a combined cohort study to focus research priorities on chronic HIV-related comorbidities; Update from NIDA on the domestic opioid crisis and HIV; Updates from OAR staff on trans-NIH cost sharing for funding areas of science that have both HIV/AIDS and non-AIDS-related components; Updates on OAR development of a two-year trans-NIH plan for HIV-related research for FY 2019-20, and plans for multi-year plans after that transitional year (up until now, trans-NIH plans have been prepared annually); Status of the reorganization of AIDS and Related Research (AARR) integrated review group study sections by the CSR; Updates on HIV-related research portfolios of several NIH Institutes, Centers and NIH/OD Offices (NCI, NIA, NICHD, NIMH and OD/ORIP); The Council also advised on the activities of the five HHS HIV/AIDS Treatment Guideline panels of experts in HIV care who, constituted as Working Groups of the OARAC, maintain updated federally approved medical practice guidelines for HIV/AIDS care and treatment.

20b. How does the Committee balance its membership?

The OARAC is composed of eighteen authorized members, twelve of whom are authorities in the fields of molecular biology, immunology, virology, neurology, pediatrics, vaccine development, antiviral development, clinical care, animal model research, retrovirology, structural biology, infectious disease, epidemiology, mental health, and substance abuse/addictions sciences. Six public members have expertise in public policy, health policy, economics, and management.

20c. How frequent and relevant are the Committee Meetings?

The OARAC meets approximately three times a year and provides advice on a continuing basis on the direction of the NIH AIDS research program, the development and annual review of a comprehensive plan for the conduct and support of all AIDS activities of the agencies of NIH, including direct involvement in budget projections for carrying out the plan which includes an estimate of the number and type of personnel needed for OAR. The Committee conducted three meetings on the following dates: 11/16/2017, 03/27/2018 and 07/12/2018.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The committee and membership requirements are specifically addressed in statute. AIDS research is conducted throughout the NIH, which includes 23 institutes and Centers, and 3 NIH OD Offices. The OARAC is the only council with advisory responsibilities applicable to the entire NIH AIDS research program. Therefore, it is essential to the coordination of the NIH AIDS scientific effort and research direction of the agency's AIDS programs.

20e. Why is it necessary to close and/or partially closed committee meetings?

The November 16, 2017 OARAC meeting was partially closed in accordance with section 10(d) of the Federal Advisory Committee Act (FACA) and provisions set forth in sections 552b(c)(6) and 552b(c)(9)(B), Title 5 U.S.C. The proposed closed portion of the meeting included the review, discussion, and Council amendment or approval of the recommendations from the Working Groups of the OARAC that update the HHS Treatment and Prevention Guidelines for medical care of people living with HIV in the United States. The premature disclosure of information which would be likely to significantly frustrate implementation of a proposed agency action.

21. Remarks

There were no formal, substantive committee reports made to the Agency, the President, or the Congress in FY 2018. Members Agosto-Rosario, Diclemente, Gandhi and Kuritzkes were administratively extended until 3/30/2018. Dr. Raab-Traub was assigned as the National Cancer Advisory Board representative to OARAC as required by the Charter. In FY 18, Dr. Goodenow, in the DFO capacity, was replaced by Dr. Jay R. Radke, Supervisory Health Science Administrator. Mary Jane Rotheram-Borus, Ex-officio, was removed by the Exec Sec in FY17 and is no longer on the Council.
