20a. How does the Committee accomplish its purpose?

Section 492 of the PHS Act states that The Secretary...shall by regulation require appropriate technical and scientific peer review of -- (A) applications...; and (B) biomedical and behavioral research and development contracts. This committee is composed of recognized biomedical and behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of funding applications and proposals, including but not limited to the scientific and technical merit of applications for grants-in-aid for research, research training, or research-related grants and cooperative agreements, or contract proposals relating to scientific areas relevant to epidemiologic or demographic research relating to the change, composition and structure for human populations and various dimensions of health. During this reporting period the committee reviewed 2,454 applications requesting \$5,143,810,799.00

20b. How does the Committee balance its membership?

The members of this committee are authorities knowledgeable in the various disciplines and fields relating to epidemiologic or demographic research relating to the change, composition and structure for human populations and various dimensions of health.

20c. How frequent and relevant are the Committee Meetings?

The committee held 33 meetings during this reporting period.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This committee is composed of recognized biomedical and/or behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of funding applications and proposals, including but not limited to the scientific and technical merit of applications for grants-in-aid for research, research training, or research-related grants and cooperative agreements, or contract proposals. These evaluations and recommendations can not be obtained from other sources because the specialized, complex nature of the applications and proposals requires a unique balance and breadth of expertise not available on the NIH staff or from other established sources.

20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the committee were closed to the public for the review of grant applications. Sections 552b(c)(4) and 552b(c)(6) of the Government in the Sunshine Act permit the closing of meetings where discussion could reveal confidential trade secrets or commercial property such as patentable material and personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

21. Remarks
