**20a. How does the Committee accomplish its purpose?**

Section 492 of the PHS Act states that The Secretary...shall by regulation require appropriate technical and scientific peer review of -- (A) applications...; and (B) biomedical and behavioral research and development contracts. This committee is composed of recognized biomedical and behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and/or contract proposals in the fields of oncological sciences. During this reporting period the committee reviewed 1,442 applications requesting \$2,502,205,460.00.

**20b. How does the Committee balance its membership?**

The members of this committee are authorities knowledgeable in the various disciplines and fields relating to cancer etiology, cancer genetics, cancer molecular pathobiology, molecular oncogenesis tumor cell biology, tumor microenvironment and tumor progression and metastasis. .

**20c. How frequent and relevant are the Committee Meetings?**

The committee held 23 meetings during this reporting period.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

This committee is composed of recognized biomedical and/or behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and contract proposals. These evaluations and recommendations can not be obtained from other sources because the specialized, complex nature of the applications and proposals requires a unique balance and breadth of expertise not available on the NIH staff or from other established sources.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

The meetings of the committee was closed to the public for the review of grant applications. Sections 552b(c)(4) and 552b(c)(6) of the Government in the Sunshine Act permit the closing of meetings where discussion could reveal confidential trade secrets or commercial property

such as patentable material and personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

## **21. Remarks**

This committee did not produce any public reports during the fiscal year. Due to the assignment of responsibilities within the Center, the roles of the committee designated federal official and committee decision maker are filled by the same individual. Drs. Yali Dou and Jennifer Yu were reassigned to the role of chairperson during the fiscal year. Dr. Jennifer Yu was reappointed during the fiscal year. The following members' terms ended early: Dipanjan Chowdhury (5/31/2023), Elizabeth Maher (6/30/2023), George Miller (02/17/2023), Irina Stepanov (5/31/2023), Alicia Timme-Laragy (5/31/2023), Alessandro Vindigni (5/31/2023), Robert Weiss (5/31/2023), and John Wise (6/30/2023). One member who retired in FY 2020 was inadvertently included in the FY 2021, and FY 2022 reports - Dr. Wenyi Wei (07/01/2019 - 12/18/2020). Dr. Kevin Janes was incorrectly reported as a member of this committee with term dates 7/1/2019-6/30/2023 on the 2019, 2020, 2021 and 2022 fiscal year reports. Dr. Howard Crawford's non-chair term end date was incorrectly reported on the FY 2022 Members list as 6/30/2023. The correct term end date is 6/30/2024. Due to the large number of members serving on this committee, NIH staff are unable to provide additional information on Occupation or Affiliation. The NIH dual peer review system is mandated by statute in accordance with section 492 of the Public Health Service Act. The charge to this committee is to determine scientific and technical merit of the individual grants or contracts. These recommendations are forwarded to Federal officials who generally accept the committee's recommendations and favorable applications are then forwarded for the second level of review performed by Institute and Center (IC) National Advisory Councils or Boards. Only applications that are favorably recommended by both the initial peer review committee and the Advisory Council may be funded.

submitted to the NIH. It is these Institutes or Centers and their advisory councils that make funding decisions. NIH Peer Review Committees are involved in the initial review of research grant applications. The NIH dual peer review system is mandated by statute in accordance with section 492 of the Public Health Service Act. The charge to this committee is to determine scientific and technical merit of the individual grants or contracts. These recommendations are forwarded to Federal officials who generally accept the committee's recommendations and favorable applications are then forwarded for the second level of review performed by Institute and Center (IC) National Advisory Councils or Boards. Only applications that are favorably recommended by both the initial peer review committee and the Advisory Council may be funded.

review of the project budget, assessment of the applicant's management systems, determination of applicant eligibility, and compliance with public policy requirements. After all these steps have been completed, NIH officials make funding decisions on individual grant applications.
