20a. How does the Committee accomplish its purpose?

Section 492 of the PHS Act states that The Secretary...shall by regulation require appropriate technical and scientific peer review of -- (A) applications; and (B) biomedical and behavioral research and development contracts". The Council is composed of both scientific and public members who provide the second level of peer review; advice on policy development, program implementation and evaluation; and research needs and opportunities of the Institute. The Council reviewed and recommended for funding 1,719 applications requesting \$924,188,661. The membership was provided with presentations on the Double-burden of Heat stress and Maternal Malnutrition on Maternal Child Health Outcomes;

Voice of the Participant (Impact of climate changes on the day-to-day lives of the women and their family members in Thatta Pakistan: voices of local community); Research supported by the Gabriella Miller Kids First program on structural birth defects and childhood cancer; Voice of the Participant (Patient Advocate, founder of the Smashing Walnuts Foundation and Gabriella Miller's mother); Young Women's Health: Supporting Adolescents, Young Adults and Their Families; Voice of the Participant (Physical health and quality of life in childhood cancer survivors). The members reviewed and deliberated the following Institute Proposed Initiatives: 1) New Approaches for Measuring Brain Changes Across Longer Timespans 2) Collaborative rare diseases research for long-term follow-up of newborn screening conditions 3) NICHD High Priority Research Projects 4) Academic Research Enhancement Award for Undergraduate-Focused Institutions 5) National Centers for Translational Research in Reproduction and Infertility 6) HEAL Initiative: Outcomes of Babies with Opioid Exposure 7) IMPROVE Initiative 8) The Road to Prevention of Stillbirth 9) Center for Collaborative Research in Fragile X and FMR1-Associated Conditions 10) Optimizing Health of Children and Adolescents with Perinatal HIV Exposure 11) Women's Reproductive Health Research 12) Population Dynamics Research Infrastructure Program. To address the burden of stillbirth on U.S. families, the fiscal year (FY) 2022 Consolidated Appropriations Act (P.L. 117-103) included funds and report language for HHS to establish a Task Force to examine: current barriers to collecting data on stillbirths throughout the United States; communities at higher risk of stillbirth, the psychological impact and treatment for mothers following stillbirth and known risk

factors for stillbirth. At the request of HHS, NICHD formed the Stillbirth Working Group of Council, to take on this task. The work group convened four sessions (October 20, 2022, November 22, 2022, December 9, 2022, and January 5, 2023) to discuss its four focus areas and to hear the personal perspectives of people who have experienced a stillbirth. In January 2023, the work group presented its findings and recommendations to Council, which unanimously approved its recommendations. The work group released its final report to HHS (Working to Address the Tragedy of Stillbirth), on March 15, 2023.

20b. How does the Committee balance its membership?

The Council will consist of not more than 18 members appointed by the Secretary (appointed members) and at least 6 nonvoting ex officio members. The nonvoting ex officio members will include the Secretary; the Director, NIH; the Director, NICHD; the Under Secretary for Health of the Department of Veterans Affairs; the Assistant Secretary of Defense for Health Affairs (or their designees); a representative from the Maternal and Child Health Bureau, Health Resources and Services Administration; and such additional officers or employees of the United States as the Secretary determines necessary for the Council to effectively carry out its function. A member of the National Advisory Board on Medical Rehabilitation Research, National Center for Medical Rehabilitation Research, NICHD, will act as a nonvoting liaison representative to ensure adequate communication on critical issues of concern to both committees. Of the appointed members, two-thirds will be selected from among the leading representatives of the health and

scientific disciplines (including not less than 2 individuals who are leaders in the fields of public health and the behavioral or social sciences) relevant to the activities of the Institute, particularly representatives of the health and scientific disciplines in the area of obstetrics, gynecology, pediatrics, genetics, perinatology, reproductive biology, developmental biology, physiology, biochemistry, endocrinology, nutrition, medical rehabilitation, child development, demography, and pharmacology. One-third of the appointed members will be appointed by the Secretary from the general public and will include leaders in the fields of public policy, law, health policy, economics, and management.

20c. How frequent and relevant are the Committee Meetings?

The committee conducted three Council meetings during this reporting period on the following dates: January 24-25, 2023; June 6-7, 2023; and September 6-7, 2023. The National Advisory Child Health and Human Development Council provides advice on a continuing basis on the type of scientific research programs that should be supported and on how to carry out the designated mission and responsibilities of the Institute. It also provides gynecology ongoing review of the relevance and effectiveness of the existing programs.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The National Advisory Child Health and Human Development Council is composed of both scientific and public members who provide the second level of review for research grant applications; advise on policy development, program implementation and evaluation; and

research needs and opportunities of the Institute. The quality, scope, and balance of advice from this Council cannot be obtained from NIH staff or from other established sources because the membership of the Council is constituted to meet the specific requirements of the mandated mission of the Council and of the Institute.

20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the National Advisory Child Health and Human Development Council were partially closed to the public for the review of grant applications. Sections 552b(c)(4) and 552b(c)(6) of the Government in the Sunshine Act permit the closing of meetings where discussions could reveal confidential trade secrets or commercial property such as patentable materials and personal information, the disclosure of which would constitute a clearly unwarranted invasion of privacy.

21. Remarks

Committee Function: Other - National Scientific and Advisory. Ex Officio Members: Dr. Lopato retired 6/8/23 and has been replaced by Dr. Li. Members: Dr. Bianchi was reappointed until 11/20/2024 and her terms has been updated. Dr. Dorn has been reappointed until 11/30/2025 and the start date was incorrectly reported on the 2020, 2021, and 2022 ACRs; her term has been updated with the correct start date (12/1/2012). Dr. Tabak's title has been updated. Members Egan, Jain, Lavender and Resick were reported as starting 12/1/2019 on the 2021 and 2022 ACRs; the correct start date is 8/30/2020 and their terms updated.

In addition, prior to an award or funding being made, NIH staff must conduct an administrative review for a number of

other considerations. These include alignment with NIH's funding principles, review of the project budget, assessment of the applicant's management systems, determination of applicant's eligibility, and compliance with public policy requirements. After all the steps have been completed, NIH officials make funding decisions on individual grant applications.
