20a. How does the Committee accomplish its purpose?

NACMCF provides impartial, scientific advice, and/or peer reviews to Federal food safety agencies for use in the development of an integrated national food safety systems approach that assures the safety of domestic, imported, and exported foods. The purpose of the Committee is accomplished by providing advice contained in the

Committees' final adopted reports. NACMCF advice is often used in the Agency's food safety programs. For example, the report addressing the FSIS charge, "Enhancing Salmonella Control in Poultry Products", that was adopted on November 15, 2022, was one of the key activities to gather data and information and provide recommendations for the agency to consider in the USDA Salmonella Framework in 2024. The 2023-2025 term committee is working on a Genomics charge for FSIS and a charge on Cronobacter spp. in powdered infant formula for FDA. This highlights how the programs of other Federal agencies concerned with food safety also benefit from the NACMCF's work.

20b. How does the Committee balance its membership?

NACMCF allows our federal food safety agencies to collaborate with the highest level of scientific expertise, gaining advice and input to US food safety programs. The Committee consists of renowned expert microbiologists, epidemiologists, risk assessors, and scientists from related disciplines from industry, academia, federal and state governments, and other organizations to ensure that the membership is balanced among a range of scientific interests. Geographic location is also considered to provide that perspectives from multiple regions of the USA are represented. In addition, the NACMCF Executive Committee, which consists of key managers from the five Federal Agencies involved in food safety, reviews the candidates and carefully selects the composition of membership by matching scientific expertise to the future work of the Committee.

20c. How frequent and relevant are the Committee Meetings?

The NACMCF full committee meets once or more per year to address specific scientific and technical questions posed by the sponsoring agencies. The subcommittees will meet as deemed necessary by the DFO and Chair.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Committee's advice helps protect public health by generating food safety advice for US food safety programs, the food industry, and consumers. The Committee allows federal food safety agencies to collaborate with scientific experts and obtain outside expertise on important food safety issues that represents the scientific perspective, experience, and point-of-view of all stakeholders. The NACMCF provides an important source of specialized scientific and technical advice that can support decision-making and recommendations that can be incorporated into Agency programs. The NACMCF serves to enhance the safety of our food supply, and this is in the public interest and assists the federal sponsors in meeting their statutory responsibilities. NACMCF also serves as an excellent public forum for sharing and receiving input on food safety and public health issues related to the microbiological criteria for foods.

20e. Why is it necessary to close and/or partially closed committee meetings?

21. Remarks

The National Advisory Committee on Microbiological Criteria for Foods provides scientific advice to US food safety programs. The Committee serves to enhance the safety of our nation's food supply, which is in the public interest and assists the federal sponsors in meeting their statutory responsibilities. The Committee held three plenary meetings in FY24, one of which was in-person. On November 15, 2022, the Committee adopted the report, "Response to Questions Posed by the Food Safety and Inspection Service: Enhancing Salmonella Control in Poultry Products" at a virtual Plenary meeting. The report provided FSIS with nine recommendations to consider on what types of microbiological criteria FSIS might use to better prevent Salmonella infections associated with poultry products. This report was published in the Journal of Food Protection in FY24 and was one of the key activities to gather the data and information necessary to support the USDA Salmonella Framework and proposed rule. In FY23, the Committee adopted the final report with four recommendations to respond to the Cyclospora cayetanensis in produce charge. In FY24, the Committee did not complete any final reports so there were no recommendations made in FY24. The 2023-2025 term committee is working on a Genomics charge for FSIS and a charge on Cronobacter spp. in powdered infant formula for FDA and will complete their final reports and recommendations in FY25.
