20a. How does the Committee accomplish its purpose?

The purpose of the Secure Rural School and Community Self-Determination Act Resource Advisory Committee is to provide advice and recommendations to the Forest Service consistent with Division C, Title VI of Public Law 110-343. The Act describes the duties of the committees as follows: to review projects proposed by counties and other interested parties; to recommend projects and funding; to provide early and continuous coordination with Forest Service officials; to provide frequent opportunities for citizens, organizations, tribes, land management agencies and other interested parties to participate openly and meaningfully, beginning in the early stages of project development; to monitor projects approved under the Act; to advise the designated federal official on the progress of monitoring; and to make recommendations for any appropriate changes or adjustments to projects being monitored.

20b. How does the Committee balance its membership?

The committee is comprised of 15 members, five in each of three categories prescribed in the Act. Within each category, the Act identifies specific interests members are to represent. Committees are formed in geographic areas to ensure each national forest located within a participating county or counties has access to a resource advisory committee. The Act requires members to be residents of the state or states within which the committee has jurisdiction.

20c. How frequent and relevant are the Committee Meetings?

The committee generally will meet 1-4 times per year as needed to perform its duties, or as often as needed.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The RAC is necessary to improve collaborative relationships among the people that use and care for the National Forests and to provide advice and recommendations to the Forest Service concerning projects and funding consistent with Title II of the Act.

20e. Why is it necessary to close and/or partially closed committee meetings?

All meetings are open to the public.

All recommendations have been completed from FY15 and prior - or 30 projects. Of the 14 recommendations from FY16 RAC meeting, 11 have been completed. Of the 11 completed, 1 proposed project was no longer viable due to major stream erosion due to water run-off from the Brian Head Fire Scar. This project was the Parowan City Trails Bridge. As the Dixie Resource Advisory Committee did not have full voting quorum, the Forest contacted Parowan City as the partner on this project and proposed that we use the Caveat set-up by the RAC, when these projects were voted on - which was Hells Backbone Road Drainage Maintenance [project] – The funding on this project may increase should the other approved projects not utilize their authorized amounts. Parowan City concurred. So 30 projects have been completed from years prior to FY16, and 11 of the 14 recommended in FY16 meeting, for a running total of 41 out of 44 total projects completed.

What is the approximate Percentage of these recommendations that have been or will be Partially implemented by the agency?

Of the projects recommended in FY16, there are 3 that have not been completed yet. Of these 3 projects: 1 is about 2/3rds spent as the work is being done by individuals on the forest and they are spending these funds each pay period. The last 2 projects are roads projects are obligating funds towards the completion thereof.
