20a. How does the Committee accomplish its purpose?

PL 112-272 established the Commission and was amended by PL 113-291, Subtitle J, Section 3091. The Commission received a \$7 million appropriation for FY21. This appropriation was used to fulfill commemorative and educational programs about WWI, to support administrative function, and to support construction and development of the National World War I Memorial. Until March 2020, no appropriated

funds were used for the development/construction of the National WWI Memorial -- up to that point, the Memorial was to be built using donated funds only. The Commission therefore entered into an MOU with The United States Foundation for the Commemoration of the World Wars (USFCWW) to serve as its principal fund raising organization for the WWI Memorial. In March 2020, PL 116-94 (WORLD WAR I CENTENNIAL COMMISSION SALARIES AND EXPENSES) lifted the prohibition on using FY20 appropriated funds for the National World War I Memorial and additionally allowed executive agencies to allocate funds and resources to the WWICC. In FY23, the appropriation was \$1 million for sustainment as the Commission awaits the completion of the sculptural element for the Memorial.

20b. How does the Committee balance its membership?

PL 112-272 provides for 12 appointments as follows: 2 members by the Speaker of the House of Representatives; 1 member by the minority leader of the House of Representatives; 2 members by the majority leader of the Senate; 1 member by the minority leader of the Senate; 3 members by the President from persons who are broadly representative of the people of the United States; 1 member by the Executive Director of the Veterans of Foreign Wars of the United States; 1 member by the Executive Director of the American Legion; 1 member by the president of the Liberty Memorial Association

20c. How frequent and relevant are the Committee Meetings?

Committee meetings are crucial to operation of Commission. Decisions central to function of the Commission are made by Commissioners at these

meetings. Meetings are held at least annually.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This Commission is established by Public Law 112-272 which law related the following findings:(1) From 2014 through 2018, the United States and nations around the world will mark the centennial of World War I, including the entry of the United States into the war in April 1917.(2) America's support of Great Britain, France, Belgium, and its other allies in World War I marked the first time in United States history that American soldiers went abroad in defense of liberty against foreign aggression, and it marked the true beginning of the "American century".(3) Although World War I was at the time called "the war to end all wars", in fact the United States would commit its troops to the defense of foreign lands 3 more times in the 20th century.(4) More than 4,000,000 men and women from the United States served in uniform during World War I, among them 2 future presidents, Harry S. Truman and Dwight D. Eisenhower. Two million individuals from the United States served overseas during World War I, including 200,000 naval personnel who served on the seas. The United States suffered 375,000 casualties during World War I, including 116,516 deaths.(5) The events of 1914 through 1918 shaped the world, the United States, and the lives of millions of people. (6) The centennial of World War I offers an opportunity for people in the United States to learn about and commemorate the sacrifices of their predecessors.(7) Commemorative programs, activities, and sites allow people in the United States to learn about the history of World War I, the United States involvement in that war, and the war's effects on the remainder of the 20th century,

and to commemorate and honor the participation of the United States and its citizens in the war effort.
