**20a. How does the Committee accomplish its purpose?**

The Aviation Security Advisory Committee (ASAC) provides a key forum for the exchange of views and information on civil aviation security issues. The committee provides recommendations to the Administrator on important security issues. The committee provides a balanced view representative of the broad range of aviation interests.

**20b. How does the Committee balance its membership?**

ASAC membership is composed of representatives of up to three nationally recognized non-governmental organizations in each of the following categories: Aircraft and Security Equipment Manufacturers; Airline Labor; Airline Management; Airport Operators; Airport Tenants and General Aviation; Aviation Consumer Advocates; Air Cargo; Law Enforcement and Security Experts; and Representatives of Victims of Terrorist Acts Against Aviation. Federal government agencies with key roles or interests in civil aviation security also attend ASAC meetings.

**20c. How frequent and relevant are the Committee Meetings?**

Meetings of the committee generally are held at least semi-annually. Meetings provide the committee opportunities to act on working group reports in a public setting whenever possible, and provide the Administrator with opportunities to review the progress of the committee and to discuss issues of concern with the committee.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

ASAC helps enhance TSA domain awareness by facilitating consultation with leading industry organizations, other non-governmental organizations (NGOs) and stakeholder representatives concerning potential risks to infrastructure, passengers and goods; response capabilities that NGOs and other stakeholders control; and the economic, social and political drivers that impact risk or response. ASAC also serves as a primary forum in which TSA gathers customer and stakeholder input concerning the effectiveness of security actions and proposals, the costs and burdens associated with security actions and proposals, and the general level of customer satisfaction TSA is engendering across affected constituencies.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

Meetings are closed only when sensitive security information (SSI) is discussed, pursuant to 5 U.S.C. Sec. 552b and 49 CFR parts 15 and 1520.

## 21. Remarks

Legislation was enacted in December 2014. The legislation exempted the committee from FACA and is no longer required to comply with the FACA database openness requirements once this ACR concludes.
