The Committee will provide recommendations to the Commission that will assist the Emergency Response Interoperability Center (ERIC) as it implements the following policy objectives: (1) the adoption of technical and operational requirements and procedures to ensure a nationwide level of interoperability; (2) the adoption and implementation of requirements and procedures to address operability, roaming, priority access, gateway functions and interfaces, the interconnectivity of public safety broadband networks, and other matters related to the functioning of the nationwide public safety broadband network; (3) the adoption of authentication and encryption requirements for common public safety broadband applications and network use; (4) the coordination of ERIC's policies with other entities, including other federal agencies; and (5) such other policies for which ERIC may have responsibilities from time to time.

# 20b. How does the Committee balance its membership?

Members will be selected to balance the expertise and viewpoints that are necessary to address effectively the issues to be considered by the Committee. Members will represent the public safety community as well as various sectors of the telecommunications industry and serve in a representative capacity. Representatives of the public safety community will be selected from state and local public safety agencies, public safety trade associations, federal user groups, and such other segments of the public safety community as the Chairman of the Commission may consider appropriate. Industry representatives will be selected from service providers, equipment vendors and other industry segments.

The Committee will meet at least two times per year.

This Committee is established for the purpose of making recommendations that will assist the Commission's Emergency Response Interoperability Center, an entity established within the Public Safety and Homeland Security Bureau, in the development of a technical framework and requirements for interoperability in order to ensure that the public safety wireless broadband network is interoperable on a nationwide basis.
