20a. How does the Committee accomplish its purpose?

The African American Advisory Committee accomplished its purpose by engaging Census leadership and managers on priority decennial concerns and strategies, identifying strategies to improve census participation within the African American population, monitoring external issues and concerns that impact Census programs or the public's participation in the decennial census, and by recommending improvements to Census programs and initiatives. During this reporting period, members provided feedback on the American Community Survey Formal Review and the Alternative Questionnaire Experiment.

20b. How does the Committee balance its membership?

The Committee was comprised of public and private sector representatives, academia, community-based organizations and research entities. The Committee provided geographical balance, representing both urban and rural populations, and different regions from across the country. The Committee also recognized the growing diversity in the Black population by including two members from the Caribbean American population.

20c. How frequent and relevant are the Committee Meetings?

The Committee generally met twice a year.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Committee's work had been useful in identifying the needs of a diverse Black population (including Carribbeans, Africans and African Americans), and the unique challenges associated

with enumerating these individuals.

20e. Why is it necessary to close and/or partially closed committee meetings?

21. Remarks

This Committee advised the Census Bureau on strategies to enumerate hard-to-count populations, particularly African American communities. The Committee's contributions to the 2010 Census included the identification of media strategies for the Black population, including Carribbean, African and African American audiences. The committee recommended appropriate messaging for this diverse population. The committee conducted significant outreach and education throughout African American populations, including faith-based audiences and Carribbean communities. In preparation for the 2020 Census, the agency will assess its needs with the goal of strengthening and expanding stakeholder advice and input through the use of technology and other means.
