objective review of PEPFAR's PMTCT activities, and provide recommendations to the U.S. Global AIDS Coordinator and the appropriate Congressional committees for scale-up of services to achieve the ambitious target of reaching 80 percent of pregnant women in countries most affected by HIV/AIDS in which the U.S. has HIV/AIDS programs. This report will be considered by Congress and the Executive Branch as they guide the program.

The membership of the Expert Panel is set by law and balanced with both US government representation from PEPFAR implementing agencies, as well as field representation from Ministries of Health, multilateral organizations, and PEPFAR implementing partners.
