20a. How does the Committee accomplish its purpose?

The Committee provides advice and recommendations to the Agency regarding the maintenance and continued development of the National Urban Search and Rescue (US&R) Response System. The Committee makes recommendations to the Agency of the level of funding required to maintain a viable urban search and rescue capability, as well as on the allocation of budgetary resources to various System activities. The Committee also reviews and recommends approval of System documentation, unresolved legal issues, and other issues that

require input of constituent organizations and subject matter experts.

20b. How does the Committee balance its membership?

The balance of membership within the US&R Advisory Committee provides for representation from the various levels of local, State, and Federal government, US&R task force sponsoring organizations, and professional associations. The many echelons of functional perspective provide professional insight from various points of view. Currently, the Advisory Committee Chair is the Director of Operations Planning, Response and Recovery Directorate within FEMA. The remaining members consist of: two sponsoring agency heads, two State emergency management agency representatives, one representative of the International Associations of Fire Chiefs (IAFC), one representative of the International Association of Fire Fighters (IAFF) and a representative of the Nation's 27 Urban Search and Rescue Task Force Leaders.

20c. How frequent and relevant are the Committee Meetings?

The Advisory Committee meets at least two times per year. This frequency allows for critical Committee input into budgetary and procurement actions. Additional meetings are scheduled as needed to address specific issues and review important System documentation. The meetings are necessary to maintain a national consensus on standard operating procedures, organizational structure, equipment levels, training, and exercise requirements.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The US&R Advisory Committee is made up of prominent figures in emergency management and practitioners in the urban search and rescue field. This presence of aggregate knowledge is unique to one of the newest disciplines in the search and rescue field. As a result, the FEMA National US&R Response System has been building the only model, standards and criteria for conducting US&R on a national level. This expertise, of which only a small portion resides with the Federal government, requires a high degree of technical input that is provided by the US&R Advisory Committee. Input of subject matter experts that make up the Committee ensure the National US&R Response System maintains the highest level of readiness possible.

Narrative Description

The US&R program supports the DHS/FEMA mission primarily in preparing for and responding to disasters. It provides rapid, effective response, uses a wide range of state, local and federal capabilities, and provides timely and appropriate disaster

assistance. Originally established and designed to provide highly trained personnel and specialized equipment to rescue victims of earthquakes and collapsed structures, US&R has evolved since 1989 to respond to earthquakes, hurricanes, tornadoes, airplane crashes, gas and grain elevator explosions, large fires and the devastating terrorist attacks on the Pentagon and World Trade Center. The ability to operate in environments contaminated by hazardous materials and weapons of mass destruction reflects the latest enhancement to US&R capabilities.

Improvements to health and safety. Medical screening: Developed medical screening guidelines for annual, pre-deployment and post-deployment follow-ups for all System Members.· Effective grant making. Assisted FEMA as appropriations increased dramatically after 9/11 in recommending priorities for its preparedness and response cooperative agreements, including equipment cache lists, training development and delivery, and developing a canine training and evaluation system.· Improved service delivery. o Standardized the full equipment cache list, which will assure interoperability of equipment used by each Task Force, and will provide economies of scale in procurement of the equipment.o Developed the Type III light equipment cache list – a modular response for weather-related incidents (e.g., hurricanes).o Weapons of Mass Destruction (WMD) capability in structural collapses. Assumption that all collapsed structures may be contaminated. Preparations include personal protection equipment, WMD detection devices, decontamination equipment, other equipment to support US&R work in

contaminated environments and developed training requirements.· Implementation of laws or regulatory requirements. With major assistance from the Legal Issues Working Group (LIWG), published the first proposed rule governing the US&R System in December 2002. In 2003, LIWG assisted FEMA OGC in responding to comments on the proposed rule and preparing the forthcoming Interim Final Rule. Provided critical input to development of the Maximum Pay Rate Table to apply to Affiliated Personnel and backfill for employees of for-profit Participating Agencies.

· Reorganized priorities. FEMA worked closely with the Committee and its Working Groups to adjust priorities in direct support of Task Force operations. These included funding for preparedness grants, ground transportation, canine training and evaluation, full scale Task Force/Incident Support Team exercises and development of those exercises, standardization of standard and Type III equipment caches, expanded warehousing for storage and maintenance of equipment, and development and delivery of training.· Issued new regulations. Proposed regulations were published in December 2002, and Interim Final Regulations are in review within FEMA and DHS. This has been a multi-year process to get to this point, in which the Advisory Committee and its Legal Issues Working Group made (and continue to make) invaluable contributions.· Approved grants or other payments. Previously discussed above, US&R received greatly increased appropriations during the last 2-year period. The advice and recommendations for priorities and allocations of the funds were a considerable benefit to FEMA and to the US&R program, ensuring that program met the highest priorities and greatest needs of

the System Members.
