20a. How does the Committee accomplish its purpose?

The scope and objectives are to improve collaborative relationships and to provide advice and recommendations to the Forest Service consistent with the Secure Rural Schools and Community Self-Determination Act of 2000. The duties and responsibilities are to review projects proposed under Title II of the Act by participating counties and other persons, propose projects and funding to the Secretary of Agriculture under section 203 of the Act, provide frequent opportunities for citizens, organizations, tribes,

land management agencies, and other interested parties to participate openly and meaningfully, beginning with the early stages of the project development process.

20b. How does the Committee balance its membership?

Membership shall be balanced and have broad representation from within each of the three membership groups. These groups include persons who represent organized labor; developed outdoor recreation, off-highway vehicle users, or commercial recreation activities; energy and mineral development interests; commercial timber industry; hold Federal grazing permits or other land use permits; nationally and regionally or locally recognized environmental organizations, dispersed recreational activities; archaeological and historical interest; nationally or regionally recognized wild horse and burro interests groups; hold state elected office or their designee; hold county or local elected office; represent American Indian tribes; school officials or teachers; and represent the affected public-at-large.

20c. How frequent and relevant are the Committee Meetings?

Estimated Number of Meetings per Year - 2-3
Estimated Total Meetings - The RACs reviewed and recommended national forest projects for the Secretary's approval. Meetings also include 2 monitoring field trips.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This committee is essential because the resource advisory committees provide for early and continuous coordination with agency officials on forest projects and for frequent opportunities for

citizens, organizations, tribes, land management agencies and others to participate openly and meaningfully beginning at the early stages of the project development process. Advice of the committee is not available from other sources because the Act requires that resource advisory committees be formed to review forest projects and recommend the proposed projects they deem have merit to the Secretary of Agriculture for approval.

20e. Why is it necessary to close and/or partially closed committee meetings?

No meetings are closed.

21. Remarks

This committee was terminated on the advice of the Secretariat due to lapsed legislation. Agency may bring this committee back on its on authority if legislation is not forthcoming. The Snohomish County Subcommittee members were all deleted from FY07 because their appointments dates appeared to have lapsed, however a meeting was held by that subcommittee during FY07.

Narrative Description

The Resource Advisory Committees (RAC) of Oregon and Washington were mandated by Congress, under section 205 of P.L. 106-393, the Secure Rural Schools and Community Self-Determination Act of 2000. The Committee was established for two purposes: (1) to improve collaborative relationships among the people who use and care for the National Forests and the Forest Service, which manages the lands; and (2) to provide advice and recommendations to the Forest Service in identifying and

implementing broadly supported land management projects that maintain existing infrastructure, enhance forest ecosystems, and improve land health and water quality. The RAC directly supports the agency's mission goal for ecosystem health: to promote ecosystem health and conservation using a collaborative approach to sustain the Nations's forests, grasslands, and watersheds. This law provides a mechanism for local community collaboration with federal land managers in recommending projects to be conducted on federal lands or that will benefit resources on federal lands. PL 106-393 is crucial to rural counties for their long-term success; both for schools and their role in helping devise key projects for the health of the land (through RAC work). RACs have fostered a solid working partnership, between forests and their county leaders as well as among RAC members. In Oregon and Washington there are 17 Resource Advisory Committees under P.L. 106-393. RACs identify on a state-wide basis that vegetation treatment and fuels management is a top priority for the highest risk areas and work with willing communities to reduce the overall threat of catastrophic fire. Furthermore, the collaborative process the RACs foster is unbounded and well-received throughout Oregon, Washington and other states that host RACs.
