21. Remarks

The Task Force was established in the Farm Security and Rural Investment Act of 2002, but did not receive appropriations in the FY 2003 Omnibus Appropriations Bill. H.R. 1559, the Emergency Wartime Supplemental Appropriations

Act of 2003 included the language that will allow the Task Force to operate, and modified the purpose as well. These modifications have been included in the new charter.
