**20a. How does the Committee accomplish its purpose?**

The council approved the Annual Interpretive Plan. The council recommended that the NPS take steps to compile information on archeology along the entire route. The council appointed a subcommittee to work on a promotional package incorporating Jack Williams and Cindy Krug's work. (Subcommittee members are Cindy Krug, Jack Williams, Carlos Herrera, Andy Amann, and Roy Ross) The council recommended that the NPS and supporters work on extended trail trip events possibly in Coyote Canyon, Los Angeles County,

or the route from Nogales to Tucson. The council appointed a subcommittee to develop a freestanding, advisory, fund-raising 501C3 organization. By a unanimous show of hands, the council members agreed to serve on such an organization. (Subcommittee members are Andy Mills, Steve Anderson, Rich Rojas, Jeannie Gillen, Andy Amann, Jack Williams, and Mike Weber) The committee agreed to meet again on November 13-14, 2004 at Mission San Antonio de Padua, Monterey County, California.

**20b. How does the Committee balance its membership?**

The Committee's enabling legislation prescribes membership not to exceed 35, as follows: (a) the head (or designee) of each Federal Department or independent agency administering lands through which the trail route passes; (b) a member to represent each State through which the trail route passes, and such appointments shall be made from recommendations of the Governor of each respective State; and (c) one or more members representing private organizations (including corporate and individual land owners and land users), which in the opinion of the Secretary have an established and recognized interest in the Trail, and such appointments shall be made from recommendations of the heads of each organizations.

**20c. How frequent and relevant are the Committee Meetings?**

Meetings were generally held once a year to identify goals and objectives and collectively address special issues or concerns of the public.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The Council is to advise the Secretary of the Interior on matters relating to the Juan Bautista de Anza National Historical Trail; including, but not limited to, the selection of rights-of-way, standards for the erection and maintenance of markers along the trail, and the administration of the Trail. The Trail comprises the overland route traveled by Lieutenant-Colonel Juan Bautista de Anza of Spain during the years 1775 and 1776 from Sonora, Mexico, to the vicinity of San Francisco, California, of approximately 1,200 miles through Arizona and California. It traverses lands which are owned by federal, state, and local governments, as well as privately-owned lands. The lands remain under those auspices and active consultation is needed with all groups. The Council recommends actions to help preserve trail resources and maintain working relationships with trail partners.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

All meetings are to be open.
