**20a. How does the Committee accomplish its purpose?**

The Combined Arts Panel is responsible for the review of applications for funding in all disciplines, primarily relating to agency goals in the areas of Artistic Creativity and Preservation, Access, and Arts Learning. This involves making qualitative judgments on the merits of each application and reaching consensus on which applications should be recommended for funding. These recommendations are carefully reviewed by the National Council on the Arts and finally by the Chairman of the National Endowment for the Arts. In over 35 meetings generally ranging from one to five days each, this Endowment Committee reviewed over 3,200 applications in FY 04, requesting approximately \$161,000,000 and recommended approximately 1,580 grants totalling approximately \$39,000,000. The committee assessed program policies and made recommendations for future guidelines regarding categories of funding, eligibility and review standards, application procedures, and types and amounts of grants to be awarded. The Endowment followed approximately 96% of the Committee's funding recommendations.

**20b. How does the Committee balance its membership?**

The Combined Arts Panel includes persons who have a depth of knowledge about more than one artistic discipline, professional artists in a wide range of disciplines, arts presenting professionals, folklorists, arts administrators, educators, critics, scholars, foundation executives, state, local or regional arts agency representatives, informed lay persons and others who bring a wide range of experience and a diversity of professional viewpoints to the work of the panel. The panel also includes a broad geographic and cultural representation as well as a reasonable balance of men and women.

**20c. How frequent and relevant are the Committee Meetings?**

Meeting dates were determined by the deadlines for applications in each area, the number of applications or nominations to be considered, and the dates on which panel recommendations on grants and guidelines needed to be considered by the National Council on the Arts. The Committee held approximately 40 meetings in 2004, and has now been merged with four other committees to form the Arts Advisory Panel.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The cost of employing Federal staff with the same broad range of professional expertise would be prohibitive. Also, qualitative judgments in the diverse areas of aesthetics, artistic expression and creativity are best provided by professionals who work or have expertise in the various artistic disciplines. There is no other established body which could meet the special advisory needs of

this unique and continually evolving program.
