# 20a. How does the Committee accomplish its purpose?

The primary function of the Committee is to review research applications. The Committee advises the Administrator, HRSA, and the Secretary, HHS, regarding research grants in maternal and child health and reviews applications for grants to improve the operation, functioning, general usefulness, and effectiveness of maternal and child health services. The research projects that the Committee approves are considered to be top

notch and cutting edge research related to the field of maternal and child health. These study results are published in prestigious medical journals such as JAMA, Pediatrics, Obstetrics and Gynecology, and the New England Journal of Medicine. As being recognized by the scientific community, these peer-reviewed journals have a broad definition of what is medical, and they have become an increasingly important forum for public health, epidemiological and behavioral science research. The Maternal and Child Health Research Program considers the publication of articles in peer-reviewed journals based on the findings produced by the research projects it supports, the ultimate measure of program accomplishment. These published peer-reviewed articles are the center piece of many of our dissemination activities and, particularly, of our research-to-practice efforts directed at the Title V State MCH and CSHCN Programs. The average number of published articles per funded project is 5.1, which is considered highly productive by the extramural research community.

## 20b. How does the Committee balance its membership?

Fourteen (14) members are appointed by the Secretary. Members must be knowldegeable in the fields of academic maternal and child health, biostatistics, child development, cultural anthropology, oral health, health economics, epidemiology, health services research, nursing, obstetrics and gynecology, pediatrics, psychometrics, maternal and child health state program administration, social work, and sociology.

# 20c. How frequent and relevant are the Committee Meetings?

The Committee met two times in FY 2004. The overall mission of MCHB is to improve the health and well-being of all mothers and children in the Nation. The Committee and the MCH Research Grants Program are units of MCHB. The primary function of the Committee is to review research grant applications submitted to the MCHB for funding. Without the Committee, the evaluation of all research proposals received would be very difficult to judge in an objective manner. Also, the technical quality and the scientific merit of the grant proposals would be difficult to assess. The Committee's evaluation on research grants is based on the proposal's compatibility with the mission of MCHB and the potential impact on improving health programs for mothers and children throughout the Nation. Based on the above undertakings, the Committee is meeting its mission and is therefore essential to the conduct of Agency business.

## 20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Committee must have scientific expertise covering broad areas of maternal and child health. For example, there must be clinical and program knowledge covering such diverse areas as normal and abnormal aspects of pregnancy, fetal development, congenital malformations, perinatal insults, labor and delivery aspects of pregnancy, neonatology, newborn intensive care, crippled children's programs, mother-child interactions, early development, behavioral and social aspects of child development, adolescence, and the delivery of health services to mothers and children, to mention just a few elements of the research program. The Bureau, under which the research program operates, is primarily a service oriented organization, and the professionals

capable of reviewing applications involving such an array of subjects do not exist in the agency. Other agencies do not focus on the clinical and program aspects of the delivery of health services to mothers and children and thus do not have committee membership knowledgeable in the most important aspect of our program. A consultant type of review carried on by mail would be cumbersome and not do justice to the applicant, as a full discussion of each application can best determine the merit of that application subject.

## 20e. Why is it necessary to close and/or partially closed committee meetings?

A portion of the meetings were closed because it involves the review, discussion, and evaluation of individual grant applications. These application documents contain information of proprietary nature of which the disclosure would constitute a clearly unwarranted invasion of privacy.
