20a. How does the Committee accomplish its purpose?

Through an annual meeting the Committee provides general advice on the direction for wildland fire research, as well as advice on specific proposals to assist the Governing Board of the Joint Fire Sciences Program (Department of the Interior - USGS, BLM, BIA, FWS and NPS, and the Department of Agriculture - Forest Service) in deciding the nature and type of applied research to address wildland fuels problems. Committee Chair also coordinates Committee review of the program, issues and proposals via phone and email. In 2002 the Committee met in Boise, Idaho to review past and current research and make additional recommendations for research in 2003 and beyond. Because of the

controversial nature of increased wildland fuel treatments on public lands, specific recommendations included additional social science research as it relates to wildland fire and fuel management. The Committee also participated in a comprehensive review of the Joint Fire Science Program.

20b. How does the Committee balance its membership?

Committee is composed of 15 Federal and 15 non-federal members. Federal Members will represent the U.S. Department of the Interior, through the Bureau of Indian Affairs, Bureau of Land Management, National Park Service, and U.S. Fish and Wildlife Service, and the U.S. Department of Agriculture, through the Forest Service. Non-Federal members have special expertise that qualifies them to provide advice from among the following categories: wildland fire management, wildland fuels management, wildland fire research, natural resource management (especially air quality management, hydrology, and soil science), forest ecology, public lands management, conservation, social sciences, tribal governments, modeling and computer applications, and the public at-large.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

To assist and advise the Secretary of the Interior and the Secretary of Agriculture, through the Joint Fire Science Program Governing Board (Governing Board), on priorities and strategies for

completing wildland fire and fuels research and implementing research findings, and oversight of the Joint Fire Science Program. Funding was provided in the FY 1998 Appropriations Act for Interior and Related Agencies to develop and deliver to Congress a Joint Fire Science Plan. This Plan indicates that a Stakeholder Advisory Group is essential to ensure broad exposure, collaboration and consensus advice prior to undertaking research projects designed to address wildland fuels problems. The Committee provides the Joint Fire Science Program with a broad perspective on the best science needed to effectively manage fuels on wildlands and reduce risks to both communities and the environment.
