### 20a. How does the Committee accomplish its purpose?

On March 31, 2003, the President's Commission on Educational Excellence for Hispanic Americans (Commission) presented to the President its final

report, *From Risk to Opportunity: Fulfilling the Educational Needs of Hispanic Americans in the 21st Century*. The report contained six (6) recommendations for increasing the educational attainment of Hispanic Americans, which encompassed the entire education continuum - from early childhood through postsecondary education, as well as federal accountability and coordination, and research. The Commission terminated thirty (30) days after submitting its final report to the President.

**20b. How does the Committee balance its membership?**

The Commission consists of 24 members, including four ex-officio members from the Departments of Education, Housing and Urban Development, Treasury and the Small Business Administration. The members are a diverse group of representatives from education, business, the community, and professional organizations. Enedelia Schofield of Oregon and Frank Hanna of Georgia serve as Co-Chairs of the Commission.

**20c. How frequent and relevant are the Committee Meetings?**

The Commission held two committee meetings in fiscal year 2003. The meetings were held in New York, N.Y. and Washington, D.C. The meetings were held to hear expert testimony from members of the Hispanic community and to approve the final version of their report to the President.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

Members of the Commission bring extensive experience working with educational issues within the Hispanic community across the United States. The collective advice of the membership

addresses both the overall Hispanic community and the varying Hispanic subgroup populations within this community. Often, Federal education and education-related research does not disaggregate sufficient data to account for a diverse Hispanic population. With limited baseline data available, the members of the Commission have worked to identify these concerns to ensure that the recommendations reflected in the Final Report provide tangible solutions to closing the achievement gap.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

All Commission meetings held in fiscal year 2003 were open.

### Action Comments

Provided support for the Partners in Hispanic Education, a partnership created between the White House Initiative on Educational Excellence for Hispanic Americans and some of the nation's leading Hispanic organizations, corporate leaders, and national private entities in the important mission to improve the educational achievement of Hispanics in the United States. The goal of the partnership is to empower the Hispanic American community by equipping families with educational tools and informational resources afforded under No Child Left Behind in order to assist them in becoming stronger advocates for their children's education – from early childhood to college completion. The partners will work with local communities to reinforce positive expectations that include educational excellence, academic attainment, parental involvement and awareness, academic preparation, mentorship, engagement of the business community, accountability and enrollment in college. To accomplish these goals, partnership participants have committed to host education programs in seven pilot cities over the next several months. Each will involve a series of events including town hall meetings; educational workshops for parents, students, educators and business and community leaders; and a seminar on student financial aid and scholarships.
