**20a. How does the Committee accomplish its purpose?**

The Council provides ongoing advice to the Department of Labor through the School-to-Work Opportunities Governing Board on a range of program issues relating to the implementation of the School-to-Work Opportunities Act of 1994.

Specifically, the Council is responsible for: Assessing the progress of School-to-Work Opportunities systems development and program implementation toward achieving the goals of the

School-to-Work Opportunities Initiatives; Providing feedback and making recommendations to the Governing Board regarding the progress and direction of implementation of the School-to-work Opportunities initiative; Advising the Governing Board on the effectiveness of the new Federal role in providing venture capital to States and localities to develop School-to-Work systems; and Reporting periodically to the Governing Board on emerging issues, actions, and findings, and providing input into policy issues, as requested.

**20b. How does the Committee balance its membership?**

The Council membership is broadly representative of the wide range of stakeholders in the school-to-work community. Membership authority of 30-35 consists of individuals who represent various points of view with respect to implementation of the School-to-Work Opportunities initiative. The Council members represent the following categories: educators, employers, labor, community groups, the general public, students, parents, and State Officials. All members are expected to take part in meetings, volunteer for specific commitments and provide leadership on behalf of the constituency.

**20c. How frequent and relevant are the Committee Meetings?**

movement involves the active participation and expertise of all stakeholders in education, business, labor, parents, students, and the community together with government. The STW Advisory Council brings all the relevant players together to achieve our common goals. It mirrors at the national level the necessary local partnerships being created across the country. It helps build the broad public support so essential to meeting the School-to-Work goals. It is responsible for assessing the progress of School-to-Work Opportunities system development, providing feedback and making recommendations to the Governing Board for implementing the initiative, reporting to the Governing Board on emerging issues and providing input on policy issues. There is no other entity in either the Department of Labor, the Department of Education, or elsewhere in the Federal government that can appropriately serve these purposes.
