**20a. How does the Committee accomplish its purpose?**

Through Panel meetings held every month or so; consultations with Executive Branch officials, members of Congress, and private citizens; field trips to selected US missions abroad; and a final report issued in November 1999.

**20b. How does the Committee balance its membership?**

The membership includes senior serving and retired diplomats, experts on security, heads of companies and nongovernmental organizations, former members of Congress, and representatives of Executive Branch agencies with overseas responsibilities.

**20c. How frequent and relevant are the Committee Meetings?**

The Panel met roughly once a month. The meetings offered the members the opportunity to review the results of their and Panel staff members' research, to reach consensus on issues the Panel would address, and to discuss the elements of the Panel's final report.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

In the aftermath of the 1998 bombings of the US Embassies in Nairobi and Dar es Salaam, the Secretary of State, with the support of the President and the Congress, formed the Panel to consider the future of the US Government's overseas presence. The Panel was asked to review the value and appropriate size of the nation's overseas presence in the coming years and evaluate how best to locate, protect, staff, equip, and manage overseas posts.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

The Panel's discussions often needed to touch on classified issues.
