The membership was created to address the specific expertise requirements as contained in Executive Order 13134, Developing and Promoting Biobased Products and Bioenergy. In addition, the Committee's membership was created to ensure an appropriate mix of

stakeholder, geographic, and ethnic diversity.

No meetings were conducted for this Fiscal Year. The Committee was terminated on June 20, 2000, when the President signed The Agricultural Risk Protection Act of 2000.

This Committee was created pursuant to the requirements of Executive Order 13134, Developing and Promoting Biobased Products and Bioenergy. However, the Committee was terminated on June 20, 2000, when the President signed The Agricultural Risk Protection Act of 2000.

While the Committee has been terminated and no meetings were actually conducted, there were no plans to hold closed meetings.

**21. Remarks**

P.L. 106-224, The Agricultural Risk Protection Act of 2000, was signed by the President on June 20, 2000. Title III of that Act is the Biomass Research and Development Act of 2000. Section 306(a) of Title III establishes the Biomass Research and Development Technical Advisory Committee which supersedes the Advisory Committee on Biobased Products and Bioenergy that was established by Executive Order 13134.
