other agencies to improve educational opportunities and outcome for Hispanics of all ages; (2) increasing the participation of the Hispanic community and Hispanic-Serving Institutions in the Department's programs and in education programs at other agencies; (3) engaging the philanthropic, business, nonprofit, and educational communities in a national dialogue regarding the mission and objective of this order; and (4) establishing partnerships with public, private, philanthropic, and nonprofit stakeholders to meet the mission and policy objectives of this order."

20b. How does the Committee balance its membership?

The Advisory Commission shall be comprised of no more than 30 members appointed by the President and is to include individuals who possess relevant experience and subject matter expertise that the President deems appropriate, and who represent a variety of sectors such as education (i.e., early childhood education, elementary and secondary education, higher education, career and technical education, and adult education), labor organizations, research institutions, corporate and financial institutions, public and private philanthropic organizations at the national, state, regional or local levels.

20c. How frequent and relevant are the Committee Meetings?

The Commission did not meet in FY 2020.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The advisory commission advised the President and the Secretary of on how best to increase

academic achievement for Hispanic students.
